PRODUCT COMBINATION AGREEMENT

- 1. This agreement between *Bodypoint, Inc.* and *Mercado Medic AB* (the Parties) states that the combination of the *Bodypoint, Inc.* Postural Support Devices (see Addendum A) and *Mercado Medic* workchairs/wheelchairs (see Addendum A) in combination (Products) meets the European Medical Device Regulation concerning product combination.
- 2. The Products are both separately CE-marked devices and registered separately at corresponding Authorities.
- 3. The Parties are responsible for possible limitations in use, instructions for installation and use, risk analysis, and required documentation the medical device(s) listed in Addendums. *Mercado Medic* pledges to inform *Bodypoint, Inc.* about any design changes to its wheelchairs which may affect the safety and or function of the Products in combination.
- 4. Each Party has the product liability for its medical device. The Parties jointly have the product liability for the Products in combination.
- 5. The Parties renounce responsibility for a combination if not assembled according to each Parties installation and use instructions.
- 6. This agreement is valid from today and is subject to three months' notice for termination.
- 7. This document has been drawn up in two copies of which each Party has taken one.
